**Background:** The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

Ukraine National Identity Through Youth is a five-year, USAID-funded program that supports youth leadership towards a values-based Ukrainian identity.

In the UNITY program, the International Republican Institute is responsible for developing the civic education approach in the UNITY communities. IRI is working on the manual "Civic education: how to implement in practice" to spread the tools for youth engagement to the decision-making processes on the local level, to evolve their communities and organizations. One of the priorities is to support youth councils through this tough period in the cause of the full-scale Russian invasion of Ukraine because the perspectives of youth are as essential nowadays as ever before.

In this year's workplan (year 3) IRI is planning to help youth councils facing challenges, analyze and develop their internal structure and promote democratic values with a local partner.

The selected partner organization will cooperate with IRI to identify ways to ensure that councils are independent and provide meaningful contributions to local decision-makers and develop recommendations for council structure and activities. The partner will help youth councils to set up/develop the structure and internal policies, identify areas for meaningful engagement with local governments, work with local data to identify trends, provide public oversight (attending authority council meetings, take part in elections as supervisors, integrity of authorities etc), and help youth councils advocate for change on behalf of youth with help of the civic education curriculum modules

**Eligibility: Organizations with experience conducting capacity-building and mentorship programs for youth in various communicates in Ukraine, preferably for youth councils.**

The applicant must select 10 communities from the above table (out of 18 communities) and provide a justification for why each city was chosen to support youth councils and submit a plan for how they intend to support and assist youth councils across each community

Project ideas might include (but are not limited) youth councils' assessment, mentorship support, capacity building sessions, trainings, increasing the youth councils' independence, building partnership with local authorities, develop recommendations to advance the youth council's structure, expand the mechanism to meaningfully participate in the local decision-making processes, cooperation with IDPs, analyzing of the internal environment.

**Required deliverables during implementation:**

- Implementation schedule for project activities (including which 10 communities they plan to set up youth councils in)
- Description and breakdown of activities and milestones
- Monitoring and evaluation plan for the project
- Monthly reports to IRI Ukraine detailing all activities conducted in that monthly period
- Bi-weekly check-in calls with IRI to monitor progress of milestone schedule
- Final report detailing project outcomes in consultation with IRI

Each proposal should answer the following questions:

1. Program Objectives – How do you plan to implement the youth councils' capacity building?
2. Proposed Activities – Please describe the activities you would implement, how they would contribute to the program objectives, and benefit the youth councils in UNITY communities for the 10 chosen communities.
3. Which groups or organizations do you plan to target and engage with?
4. What experience or past success, if any, do you have working on the issues you propose to address?
5. How will you promote the activities of your project?
6. Implementation Timeline – Please briefly describe the timeline for each activity.
7. Monitoring and Evaluation – What are the results you expect to achieve? Please describe how you plan to measure and document the impact of your project (qualitative and/or quantitative results). Proposals must clearly demonstrate how the stated activities will achieve the desired results.

IRI will provide technical assistance and deliverable templates where needed with these monitoring and evaluation activities.

**Technical Applications:**

All applications must include a comprehensive explanation of the methods to be used for implementation. Applications must not exceed 10 pages. Full Application filled out and submitted both in Word (unsigned) and PDF (signed). Every question on the FAS Full

Application must be answered. If you do not have certain documents, it must be clearly explained why.

1. The first page of the application must show the following:
  - a. The name, address, UEI Number (when required) and telephone numbers of the Applicant (and electronic address if available);
  - b. A statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation and agreement to furnish any or all items for which prices are offered;
  - c. A statement concerning whether or not the applicant has received a Negotiated Indirect Rate Cost Agreement from the US Government, currently or in the past. If yes, please attach NICRA.
  - d. Names, titles, and telephone and facsimile numbers, and electronic addresses of persons authorized to negotiate on the Applicant's behalf with IRI in connection with this RFA; and

    - i. Passport ID of individual representing organization during the application, and Legal Registration as Private Entrepreneur if applying as P.E.
  - f. The application must state the organization's indirect costs recovery methodology, which must be **ONLY** one of the following:
    - i. 10% percent de minimis rate; OR
    - ii. Current NICRA approved by the US Government (must attach copy); OR
    - iii. Direct charging of indirect costs.
2. Applicants shall provide 1-2 reference letters outlining past performance in specifically conducting capacity-building and mentorship programs for youth in various communities in Ukraine, preferably for youth councils. IRI will not accept general reference letters of support.
3. Applicants shall describe experience of handling financial budgets and experience working with NGOs and roles they held.
4. Applicants shall provide a list of at least five previously executed awards of a similar nature for the last three years along with the contact details for each funder. IRI may contact the funder as a reference check.
5. Applicants shall provide a list of at least five program beneficiaries for previously executed grants of a similar nature for the last three years along with the contact details for each. IRI may contact the individuals as a reference check.
6. Applicants shall provide third-party evaluations of past activities if available.
7. All applications must include background on the organization's prior experience as it relates to the requested scope of work.
8. Resumes of all individuals who will be responsible for the programmatic and financial management of the award must be attached.
9. Describe current and past projects and funding sources and any potential impact current activities might have on this award.
10. Describe accounting practices and organizational infrastructure, as well as technology and intellectual property owned by the organization, which will be used to complete the scope of work.

11. Applicants shall provide audited financial statements and management letters for the last three years.
12. Applicants shall provide a copy of legal registration documents (for organizations) or one form of legal ID (individuals). An English translation should be attached if necessary.
13. Applicants shall provide a statement detailing revenue from the last three years.
14. If selected for award, applicant may be required to provide detailed allocation if it selects direct charging of indirect costs and has multiple sources of funding.
15. Using the attached checklist [below](#), the applicant should indicate what information will be submitted for IRI's review.

### **Cost Applications:**

The budget should be submitted in two forms: (1) a detailed, cost category budget and (2) a milestone budget.

1: Cost Category budget: A detailed budget in US Dollars including the specific line item costs outlined here must be submitted to estimate project costs. Each application should also have a detailed explanation of why the budgeted amounts are necessary for completing the scope of work. The total amount budgeted for this project must not exceed \$90,000 USD.

All one-time and recurring costs must be fully described in the budget. Rates should be quoted, inclusive of all but showing separately, costs of inspection, services, transportation, taxes, import duties if any and other levies.

- *Personnel* – In general, employees receiving benefits from the applicant organization are considered staff. Consultants hired to assist with the program, who do not receive benefits, should be included under contractual. Identify staffing requirements by each position title and brief description of duties. For clarity, please list the annual salary of each position, percentage of time and number of months devoted to the project. (e.g., Administrative Director: \$30,000/year x 25% x 8.5 months; calculation:  $\$30,000/12 = \$2,500 \times 25\% \times 8.5 \text{ months} = \$5,312.5$ ).

- *Indirect/Overhead Costs* – applicants can choose to budget directly for costs such as rent, utilities, technology, human resources and other general operating costs, **or** a de minimis rate of 10% can be applied to the total amount of direct expenses budgeted **or** the percentage of approved NICRA. **NOTE:** Organizations that have had an approved NICRA in currently or in the past, cannot use the 10% de Minimis; they must budget and report directly on the indirect costs of the project.

**Evaluation and Award Process:**

1. Applications will be evaluated by IRI for compliance with administrative requirements, previous experience of similar projects by the Applicant, technical capacity, the qualifications of the personnel for the project, and prices. IRI may contact the Applicant’s previous clients and may obtain any information related to other projects that the Applicant has executed. IRI may contact any applicant for clarification or additional information, but Applicants are advised that IRI reserves the right to make decisions based solely on the information provided with the applications. IRI may but is not obligated to conduct additional negotiations prior to issuance of a contract and may at its sole discretion elect to issue contracts to one or more applicants.
2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there were a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Applicant does not accept the correction, the offer will be rejected.
3. IRI may determine that an application is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. An application may be rejected if IRI determines that the lack of balance poses an unacceptable risk.
4. IRI will conduct a Technical/Price Weighted evaluation and source selection based on evaluation factors listed below. Technical evaluation factors have a total of 80 points; price evaluation has a total of 20 points. These factors will serve as the standard against which all technical information will be evaluated and identify the determination factors that Applicants should address. IRI intends to evaluate applications in accordance with the Statement of Work of this RFA and make an award to the Applicant achieving the highest combined score proposal (technical and cost), demonstrating both technical compliance and price reasonableness.
5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

**Evaluation of Applications:**

1. The applications will be evaluated by a technical evaluation committee using the criteria shown below. When evaluating the competing applications, IRI will consider the written technical/capability information provided by the applicants, and any other information obtained by IRI through its own research.
2. The criteria listed below are presented by major category, so that Applicants will know which areas require emphasis in the preparation of their applications.
3. IRI will evaluate applications in accordance with the technical criteria and weightage shown in the table below. A total 100 points are assigned according to the following criteria:
